- 1/22C To note those present, to receive and consider for approval, apologies for absence and reasons given.**
Schedule 12 of the Local Government Act 1972 requires a record to be kept of the members present and that this record form part of the minutes of the meeting. Members who cannot attend a meeting should tender apologies to the Parish Clerk as it is usual for the grounds upon which apologies are tendered also to be recorded. Under Section 85(1) of the Local Government Act 1972, members present must decide whether the reason(s) for a member's absence are accepted.
- 2/22C To declare any Disclosable Pecuniary Interests (DPIs), Other Significant Interests (OSIs) or Voluntary Interests (VIs) relating to items on the agenda.**
A member who declares a DPI in relation to any item on the agenda will need to leave the meeting for the whole of that item and will not be able to speak or take part unless a relevant Dispensation has been granted. A member who declares an OSI will be able to speak on the item but will be required to leave the meeting for the vote. Councillors may also declare a voluntary Interest if they are unsure of their position. Inclusion and voting will be decided at the time or the declaration.
- 3/22C To elect a Committee member to the vacant position of Chair for this committee until 2022 Annual Council Meeting.**
- 4/22C To consider and adopt the Minutes of the Ordinary Meeting held on 15 March 2021**
- 5/22C Public Open Session for members of the public who may make representations, answer questions and give evidence regarding items on the agenda or to suggest issues for discussion at a future meeting. (This item will last no more than 15 minutes)**
- 6/22C Communications strategy - Committee to consider an approach to the development of a strategy.**
- 7/22C Social Media Strategy - Committee to discuss the social media strategy steps for the next 6 months and produce a comprehensive implementation plan.**
